02-08-2022 & 3-08-2022- Cleanliness drive at the joint director office was organised in collaboration with C.K.T College of Arts, Commerce and Science.

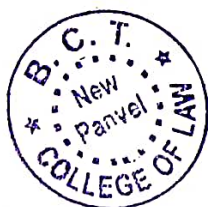
